# **How to Contact Your Legislator**

# Who are Your Legislators?

- Find out Who Your State Representative and State Senator are. There are several options to find out who your legislators are:
  - a. Visit the Legislative Website's homepage: <a href="https://legis.wisconsin.gov/">https://legis.wisconsin.gov/</a>. In the center of the homepage there is a section that says "Who Are My Legislators?" that has a text box where you can enter your address.
  - b. Use the Legislative Map: <a href="https://maps.legis.wisconsin.gov/">https://maps.legis.wisconsin.gov/</a> and enter your address in the text box on the upper right-hand corner of the webpage.
  - c. Call the Legislative Hotline: 1-800-362-9472
  - d. Map of State Representatives by County. Map of State Senators by County.
- How to Find Your Legislator's Contact Information. The state legislative website
   (<a href="https://legis.wisconsin.gov/">https://legis.wisconsin.gov/</a>) includes a comprehensive profile of each legislator that includes their phone number and email address. Look up State Representative contact information <a href="here">here</a>, and State Senator contact information <a href="here">here</a>. Click on "details" below the legislator's headshot to see their full profile, including office address, committee assignments and staff names.

# **How to Provide Input to Your Legislators About the Direct Care Workforce Crisis**

- You can Email or Call Your Legislator to Provide Input on State Budget or Legislative Items
- Whether you send an email or call your legislator, you want to make sure you cover the following:
  - a. Who are you?
    - i. Are you---a direct care worker, a direct care provider, a family caregiver, etc.
  - b. What is your issue?
    - i. Wisconsin's direct care workforce crisis
  - c. Why does this matter?
    - i. Provide examples of how the crisis is impacting you or people you know. I.e. people don't have access to needed care; family members have had to quit their jobs to care for people; providers may need to close their doors; etc.
  - d. What can your legislator do to address the issue / What is your ask?
    - i. Invest in the direct care workforce as part of the 2021-23 state budget

#### Sample Script / Email to Give You Ideas---Direct Care Workers

Dear Senator / Representative [insert name]
My name is XXXXXXXXX, and I am a direct care worker {specify personal care, CNA, nursing home, etc} that lives in your district. I currently provide care to XXXX people.

I am reaching out to ask for your support of higher pay for direct care workers. I do this work because [insert reason], but the low wages mean that I cannot make a living as a caregiver. I could make more working at Kwik Trip. [provide any examples of financial challenges—lack of benefits, working a second job, etc].

Many people in need of care have lost good workers because the pay is just too low. [provide examples of challenges faced by clients if they can't find workers—i.e. can't get out of bed, can't work, etc.]

Please increase the pay for direct care workers as part of the state budget to help address the workforce crisis.

#### • Sample Script / Email—Providers

Dear Senator / Representative [insert name]

### **How to Set up a Meeting with Your Legislators**

#### • You can Request a Formal Meeting with Your Legislator

- a. Default meeting length is 30 minutes in the Wisconsin State Capitol.
- b. Due to COVID, you will likely have a choice about whether you would like to meet virtually or in-person. You should specify if you want a virtual meeting when you set it up.
- c. You can also request to meet with your legislator at a place your community like a coffee shop or even your direct care agency (called an in-district meeting).

#### • Tips for Requesting a Meeting with Your Legislator:

- a. When you call your legislators office, ask to speak to the person who handles scheduling.
- b. Let them know your name and that you are a constituent.
- c. Tell them that you would like to set up a time to discuss issues impacting Wisconsin's direct care workforce with the Representative / Senator
- d. Specify if you would like the meeting to be virtual, at the Capitol or in the district
- e. Let them know the names of anyone else who may be joining the meeting with you
